# CONDITIONS FOR UKRAINIAN APPLICANTS FOR STUDY TOUR TO JAPAN

#### 1. Logistics and Visa

- 1. Participation in the study tour is voluntary.
- 2. Participants will depart for Japan from Warsaw.
- 3. Under Martial Law, participants must ensure their <u>eligibility to cross the border</u> and stay abroad during the training period.
- 4. <u>Visa</u> applications should be submitted to the Japanese Embassy in Kyiv (processing time: 5 working days).

#### 2. Travel to Poland

- 1. JICA will <u>reimburse travel expenses</u> to/from Poland and accommodation in Warsaw (if required) upon arrival in Japan.
- 2. Participants are responsible for <u>arranging their own</u> transportation, accommodation, and logistics in Poland.

## 3. Candidates with Military Affiliation

If a military-affiliated candidate is prioritized, please inform JICA Ukraine Office as soon as possible as Approval from the Ministry of Foreign Affairs of Japan takes up to 3 weeks.

Qualifications of applicants who belong to the military or other military related organizations and/or who are enlisted in the military will be examined by the Government of Japan on a case by case basis, consistent with the Development Cooperation Charter of Japan, taking into consideration their duties, positions in the organization, and other relevant information in a comprehensive manner.

## 4. Candidates with Medical History

Pregnant applicants are not recommended to apply due to the potential risk of health and life issues of mother and fetus. This program contains hands-on practice using construction models and site visits to construction site. To reduce the risk of worsening symptoms associated with respiratory tract infection, please be honest to declare in the Medical History

## 5. English Proficiency

If a candidate does not submit an English proficiency certificate, their proficiency must be assessed before selection.
